It was Dr Martin Luther King Jr who said: “One has a moral responsibility to disobey unjust laws.”

It's been surprising the number of Christians that have thrown up Romans 13:1 in criticizing Destiny Church's 'Stand for our Freedoms and Rights' service this Sunday at our church premises. Interesting that many of the unbelieving crowd of haters have also joined the religious blind in quoting that same Romans 13:1 passage of scripture, a scary alliance in my opinion.

So do the church or believers have such a freedom or role in confronting the State or Government of its day? Or as some are saying, it's none of our business, trust God and keep praying?

In Acts 4:25-35 there is plenty of evidence that the Church and gifted leaders will not only confront political powers, but also religious powers and the power of people who oppose them! Further to this, in Acts 4:17-20 it says by this time now the Roman political senate and the religious authorities had colluded together to threaten, what they called a cult (how ironic) named 'The Way.' This was before the heathen renamed them 'Christians', and they were charged by law not to preach that name of Jesus Christ anymore!

Now it's clear in the above passage, The Apostle Peter answered by saying “Whether it be right in the sight of God to listen to you more than God...you be the judge! But we cannot help but to speak what God wants us to speak” (Acts 4:19-20)

Now it's easy to weigh up the argument about the separation of Church and State!
